



- Port the lens onto your finger, and with your middle finger of the same hand, pull down your lower eyelid. With your index finger of your other hand, pull up your top eyelid. If you put your finger on your eyelash line, you can open your eye welle.
  Look in the mirror so that your cornea is located centrally. Sowly bring the lens dose to your eye and put it gently in place whits still locating in the mirror. You glance upwards when doing this, the lens will not be properly centred on your cornea. (Figure 2)
  When you have place the lens properly on the cornea, slowly remove your index finger and then release your eyelds, starting with the bottom lid first and then the top lid. If you renove your index neer so quickly or blink too quickly, the lens nuy change position or fall out.
